Re: Concerns regarding proposed offshore wind farm - Commercial Fisheries Research Foundation

Dear Governor Carcieri,

I am writing to express the concern of the Board of Directors of the Commercial Fisheries Research Foundation that plans to construct an offshore wind farm and to develop an Ocean Special Area Management Plan (SAMP) by the Coastal Resources Management Council (CRMC) are proceeding without adequate field research in the area of fisheries resources. The sites being considered for an offshore wind farm, and the study and planning area delineated in the Ocean SAMP that includes both state and federal waters are critical to the livelihoods of many in the Rhode Island commercial fishing fleet.

It is the Foundation's understanding that a series of four stakeholder meetings concerning the proposed offshore wind farm project were convened in 2007, and a final report was issued by the Peregrine Energy Group Inc. in February 2008. Representatives of the commercial fishing industry did participate in these stakeholder meetings, but they have indicated that when this process stopped, their opportunities to be involved in the research and design phases of the project also stopped.

In regards to the Ocean SAMP process which will result in zoning uses off the coast of Rhode Island, the Foundation is concerned that the research program currently underway does not include any fisheries field research. This program, funded in the amount of \$3.2 million, is to provide the basis of information on which a SAMP will be developed but only includes one fisheries related project – a project designed to develop commercial and recreational fisheries usage maps for the SAMP area based on fishermen's input.

It is the viewpoint of the Foundation that the establishment of important baseline information on commercially valuable fishery resources in the possible wind farm sites and the Ocean SAMP area in general is critical to mitigating any potential harmful impacts. Fishermen have expressed their concerns about the need to fully understand potential impacts on vital breeding, feeding, and nursery areas; how natural patterns of fish/crustacean behavior may change in response to wind farm construction and operations; how disturbances to the marine environment left behind from construction activities will be repaired; and how fishing vessel transit patterns and fishing activities will be curtailed during and after construction.

There is deep concern that the research program is proceeding without the involvement of the commercial fishing industry both in terms of 1) deciding what research is needed; and 2) being part of the research teams conducting the field research. This is particularly disturbing considering that the Rhode Island commercial fishing industry is a valuable resource to the state both in terms of the income it generates and the knowledge its members hold regarding the natural systems at work in our offshore waters.

The Board of Directors of the Commercial Fisheries Research Foundation concurs with commercial fishing industry leaders and others that it is important for the state to move in the direction of developing alternative energy sources to generate jobs, reduce our carbon emissions, and secure our state's energy future. While they see the value in pursuing the development of an offshore wind farm, they feel strongly that such projects need to be implemented responsibly, and with a full understanding of the potential impacts.

The Foundation's overall mission is to foster working relationships among members of the commercial fishing industry, scientists, and managers to carry out research projects that will provide pertinent information for management decisions. With this in mind, the Foundation offers its assistance to work with those involved in the wind farm proposal and the Ocean SAMP process to find a meaningful way for the commercial fishing industry to be engaged in the research, planning, and monitoring phases of the offshore wind farm proposal. From the Foundation's perspective, there is a critical need to identify potential negative impacts to fisheries resources and find solutions to potential problems early in the process so the state can move forward in these new growth areas without jeopardizing or sacrificing its existing businesses and livelihoods, or an important component of its local food supply.
